Reasons for Change in Emissions

Our reported emissions have fallen this year because we have invested in more energy efficient process equipment in our operations.

The Scope 1 categories for which we have reported emissions have changed for the following reasons:

Recording of diesel within backup generator.

The Scope 2 categories for which we have reported emissions have changed for the following reasons:

Electricity consumption – replacement of fluorescent lighting in the office with LED panels, gaining more efficiencies. Reduction in electricity consumption peripherals plus behaviour change pragmatic initiatives to reduce electricity usage, e.g., turning off lights in offices when not in use and reducing printer numbers in the office and printing requirements.

The Scope 3 categories for which we have reported emissions have changed for the following reasons:

Purchased goods and services – We have ceased procurement of plastic bubble wrap and other plastic based packaging that is not both made from recycled material and recyclable.

Business travel – Tighter departmental budgets have led to a reduction in business travel expenditure. This is realistically unlikely to be a recurring reduction given the business operational needs.

Employee commuting – Staff have reported reduced use of cars to get to work and an increase in walking, cycling, and commuting by public transport. The hybrid model of working has also reduced the emissions due to 'working from home.'

We have chosen the metric gross global scope 1 and 2 emissions in tonnes of CO2e per tonne of product output as this is a common business metric for our industry sector.
