#### Reasons for Change in Emissions

Our reported emissions have fallen this year because we have invested in more energy efficient process equipment in our operations in addition to investment in renewable energy source with the installation of solar panels.

The Scope 1 categories for which we have reported emissions have changed for the following reasons:

Diesel backup generator has not required any top up.

The Scope 2 categories for which we have reported emissions have changed for the following reasons:

Electricity consumption - replacement of fluorescent lighting in the office with LED panels in accordance with programme to replace all fluorescent lighting, gaining more efficiencies. Investment in 70 solar panels on the rooftop. 27853kwh was generated by solar in 12-month period.

Reduction in electricity consumption peripherals such as printer numbers in the office and printing requirements.

The Scope 3 categories for which we have reported emissions have changed for the following reasons:

Purchased goods and services - Capital goods purchased has reduced due to increased competitive pricing in the market and a continual move toward services offering. Our

approach at this time is still on a 'spend based' approach but we continue to look at ways with our partners at moving toward an 'activity based' approach for calculation.

Business travel – global opportunities have resulted in more air-travel, but hotel stays emissions have reduced.

Employee commuting –The hybrid model of working continues resulting in more emissions from home working but less in general waste in the office.

## Quantification and Reporting Methodology

We have continued to subscribe to Climate Essentials, a business initiative setup across various geographic locations to work with businesses to measure, manage and reduce CO2 emissions. We have measured emissions for the tax year periods 2021-2021, 2022-2023 and 2023-2024.

We have measured our scope 1, 2 and scope 3 emissions. Where we have not recorded a % for exclusions because to our knowledge we are not excluding anything from our measurements and management.

#### **Base Year**

We have a fixed base year of 2022. We chose this year as it was the first year for which we considered that we had reliable data, and it was typical in respect of our operations.

## **Targets**

Our emissions reduction target is to reduce our gross, global scope 1 and 2 emissions in tonnes of CO2e by 50% from 2022-2023. Our progress towards reaching this target has been achieved this year as planned to reduce Scope1 and Scope 2 from a combined emissions of 22.707tnCO2e in 2022-2023 to 3.5tnCO2e in 2023-2024 – a reduction of 84.5%.

## Intensity measurement

We have chosen the metric gross global scope 1 and 2 emissions in tonnes of CO2e per tonne of product output as this is a common business metric for our industry sector. Figures for the 2023-2024 period

vs the 2022-2023 period are:


